HUMBOLDT COUNTY – EXCLUSIVE OPERATING AUTHORITY (EOA) QUARTERLY SUMMARY REPORT 1ST QUARTER CY 2023

I. HISTORY –Non-competitive EOA contracts with Arcata-Mad River Ambulance (AMRA) specific to the Arcata Zone (1) and City Ambulance of Eureka (CAE) specific to the Eureka Zone (3) with ongoing coverage of southern Humboldt County (Zone 4), were executed effective January 1, 2022. Both providers are now in the monitoring stage and reporting quarterly. The following is provided as an overview with updates to this process.

III. SUMMARY OF ISSUES -

<u>Mutual Aid calls</u> – CY 2022 noted some increases in mutual aid calls. Providers reported contributing factors related to overall rises in call volumes and the implementation of Logis CAD system contributing to issues. CAE reported re-implementing tiered response system 2/1/2023.

<u>Code 3 calls – Documentation issues were impacting identification of Code 3 calls for response time monitoring.</u> There were deficiencies in completing entries for mode descriptor "eResponse.24" but now appear resolved. 4th Quarter CY 2022 and 1st Quarter CY 2023 documentation compliance was 100%. Continue to monitor and verify with Ambulance Providers' secondary review of Code 3 calls.

IV. PLANS FOR SUBSEQUENT REPORTING QUARTER-

North Coast EMS Humboldt EOA report will continue to be uploaded to North Coast EMS website each quarter for public review. Feedback welcomed and encouraged through updates provided at monthly Medical Advisory Committee (MAC) meetings and quarterly Joint Powers Authority (JPA) meetings.
