HUMBOLDT COUNTY – EXCLUSIVE OPERATING AUTHORITY (EOA) QUARTERLY SUMMARY REPORT – CY 2023

History –Non-competitive EOA contracts with Arcata-Mad River Ambulance (AMRA) specific to the Arcata Zone (1) and City Ambulance of Eureka (CAE) specific to the Eureka Zone (3) with ongoing coverage of southern Humboldt County (Zone 4), were executed effective January 1, 2022. Both providers are now in the monitoring stage and reporting quarterly. The following is provided as an overview of this process.

III. Summary of issues -

<u>Mutual Aid calls</u> – Providers previously noted call volumes, Logis CAD system contributing to increase in MA calls. CAE to re-implement tiered response system 2/1/2023.

Code 3 calls -

- 95570 has met > 100 PCRs meeting minimum threshold to calculate 90th percentile response times. Will continue to calculate based on rolling 4 quarters.
- 95525 has met > 100 PCRs meeting minimum threshold to calculate 90th percentile response times based on prior rolling 6 quarters.
